## 1.0 INTRODUCTION

### 1.1 BASES Safety Partnership

The Partnership includes:

- Operating sites in the Sarnia-Lambton region that are recognized members of BASES (Bluewater Association for Safety, Environment & Sustainability)
- Full members of the Sarnia Construction Association
- Members of the Sarnia-Lambton Building and Construction Trades Council
- Lambton College

### 1.2 Registration Application

All users may access the Registration Application to view Safety Partnership course availability and track training records for their respective bookings. Partners have global access to all training records. Others may access training records for their respective bookings. Access to information is controlled per the Safety Partnership Privacy Policy.

### 1.3 Payment Policy

All organizations that book training are responsible for making payment to the Safety Partnership (BASES). Purchases made by partners may be invoiced or paid by credit card. There is a \$50 fee for “no-shows” effective January 1, 2024. However, no fees will be charged for course cancellations prior to delivery of the course. Outstanding payments are tracked and reported to the BASES Board of Directors.

Purchases made by *non-partners* must be pre-paid using a credit card or other acceptable means. Safety Partnership course cancellations are fully refunded or rebooked if made 48 hours prior to the course date. Audit cancellations are fully refunded or rebooked if made 5 business days prior to the audit.

It includes a basic introduction to key legal requirements, safe work planning, hazard recognition and control at member sites across Sarnia-Lambton.	\$25.00	\$50.00	4 hrs
<i>Basic Safety Orientation (valid – 3 yrs)</i>	<b>BSO-BSOP.</b> This classroom-based course provides a review of safe work planning processes with a focus on hazards that are posing relatively high risk to workers across our region. This course is valid for three years and is required for entry into member sites.  <i>Prerequisites:</i> <ul style="list-style-type: none"> <li>• Proof of current WHMIS and</li> <li>• BSO-NWPT completed within previous 90 days or</li> <li>• Valid BSO or valid BSR (within 30-day grace)</li> </ul>	\$125.00	\$150.00	4 hrs
<i>Confined Space Attendant &amp; Entrant (valid – 3 yrs)</i>	<b>GEN-CSATT.</b> This awareness training program is intended to provide participants with the knowledge necessary to function as an entrant or attendant (hole watch) and to work safely in and around confined spaces. Participants will learn about regulatory requirements of Ontario Regulation 632/05.	\$100.00	\$110.00	3 hrs

<i>Fit Test Full Face Respirator (valid – 2 yrs)</i>	Designed in accordance with CSA Standard Z94.4-11, this course provides participants with the knowledge required to use a “full face” respirator. It includes personalized verification of mask sizing for the selected brand of mask.	\$50.00	30 min
<i>Fit Test Full + Half Face Respirator (valid – 2 yrs)</i>	See above half face and full-face fit test descriptions.	\$75.00	45 min

<i>Online Overhead Crane, Hoist and Rigging (valid – 3 yrs)</i>	<b>MCH-OCHRT.</b> This course is for participants expected to work with or near overhead cranes. It provides a basic understanding of the hazards and controls used to manage risks associated with bridges, full gantry, and jib (overhead) cranes.
